#### Discussion on the agenda:

- The meeting commenced at 11:15 AM in the room no. 010 ground floor.
  - Mr. Arunkumar V, IQAC & Grievance Cell Coordinator welcomed the gathering and stated the agenda to all the members. And requested the Principal Madam to begin the interaction session with students.

So the Principal Madam told them that she will speak to the subject teachers for better explanation and extra classes.
  - Students also said that the CIA examinations are very tiring if there are three core subjects in a day. So they requested to have two subjects a day, the same was agreed by the Principal.
  - Students complained that they don't have sanitary pad vending machine in the women washroom, mirrors have to be cleaned. Principal madam said them it will be done at the earliest and maintained.
  - Students said that they wanted water filter in the in the college and Madam said that the drinking water provided now is pure aero water however she assured that drinking water filter will be installed.
  - Students wanted first aid kit to be refilled regularly. Principal Madam assured hence forth there shall be no shortage of any medical needs in the kit.
